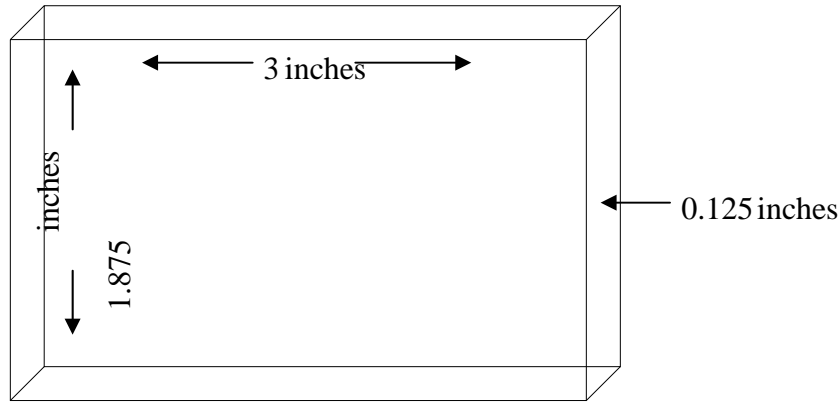

Leaf Trading Cards, LLC (LEAF) Submission Form Terms & Conditions

Items for submission must be (a) no more than 3" in length, (b) no more than 1.875" (1 7/8) in width and no more than 0.125" (1/8) in depth (see diagram below).



Window placement of your submission will be at Leaf's sole discretion. If signature does not fit the above specifications, Leaf reserves the right to return the item at the cost of the submitter. LEAF reserves the right to refuse any signature we feel is not appropriate. LEAF will NOT cut any media that is already in Trading Card Form. LEAF reserves the right to charge an additional fee for hard to cut media. In that event, Leaf will contact the customer with additional charges prior to processing the order.

In order to qualify to be custom made into a Leaf Cut Signature Executive Collection Cut Signature Card, your item must be authenticated by PSA/DNA, BECKETT, or James Spence Authentication (JSA) and individually certified with the certification sticker still intact. Auction letters will NOT be accepted as proof of authenticity. JSA Stamp of Approval will Not be accepted as proof of authenticity. If your item is not previously authenticated, LEAF can process the authentication for you by BECKETT. Pricing for authentication is determined by BECKETT fee structures. To determine those fees, please go to http://www.beckett-authentication.com/bas_authentication/pricing. If you are unable to access the Internet or to inquire about *quantity* authentication discounts, please contact a LEAF representative.

By signing the front of this form, the customer agrees that LEAF 1) is not responsible for any issues that arise from the third party authentication process and 2) is not responsible for possible damages (smears, bubbling, tears, etc.) 3) can charge additional fees for difficult or hard to cut and/or build media or otherwise and the customer agrees to hold harmless and indemnify Leaf Trading Cards, LLC from any claims.

The first **authenticated** signature submitted for a personality during a calendar year will automatically be upgraded to a Masterpiece One-of-One custom card. When determining the Masterpiece One-of-One designation, an item will not be considered until it has been fully authenticated (by the customer or LEAF). A full population report will be available on our website at www.leaftradingcards.com. The population report will be updated weekly and only include cards that have finished the entire submission process and shipped to customers.

All submissions must be packed securely and shipped to: Leaf Trading Cards, LLC – 4717 Plano Parkway Suite# 150 Carrollton, TX 75010. LEAF is not responsible for mislabeled or undelivered items. LEAF is not responsible for un-insured packages. We highly recommend sending your submission via an insured and trackable service such as UPS or FedEx.

You must include a copy of this submission form with your item. Failure to do so will render your item unsubmitable and you will be charged for any return shipping incurred.

To determine amount owed, use the 'Calculating Your Total' area on the front of this form. Total the number of cards being custom ordered and multiply by the price per card based on the chart(s) below. If using LEAF to authenticate your item, please calculate authentication fees. Calculate return postage and insurance using tables below (In order to qualify for replacement value of lost or stolen shipments, you must elect insurance coverage!).
